## CIRCULAR

Ref.: 1) Fee Waiver Scheme for SC/ST students pursuing Higher Education.

 Dayanand Bandodkar Scheme for Orphan students pursuing Higher Education.

The above schemes were formulated by the Government to ensure that no students are deprived of higher education for want of financial resources.

As per the above schemes, fee waiver consist of tuition, library, laboratory and development fees and should be granted to students at the time of admission itself.

It is observed that some colleges are charging the student the waived off fees alongwith other fees and then sends the proposal for reimbursement thereby defeating the very purpose of the schemes.

Under the above circumstances, colleges/ University are requested to follow the accompanying guidelines in respect of the above schemes:

- 1) The eligible students should be granted the fee waiver at the time of admission itself.
- 2) Other fees to be charged and collected from the students.
- Proposals to be submitted for reimbursement toward waived fees alongwith fee receipt of the student and other required documents.
- 4) The fee Receipt should be countersigned by the concerned student and the Principal of the college/ Registrar of Goa University.
- All the supporting documents submitted along with the application should be attested by the concerned authority.

Proposals should be submitted on before 30th September for reimbursement of waived off fees as per the format enclosed. No proposal will be entertained by this Directorate after cutoff date.
